
Sometime during the night on Pork Chop Hill, some shrapnel hit Dan in his wrist. At first he didn't realize he was hit. Even after he returned to the rear and the war ended he didn't notice it until one day he saw something black under his skin and he could feel it and realized it was some shrapnel.

Dan went to the battalion aide station and showed it to the medic. Dan described it this way: "The medic took a scalpel and cut the skin open, took out the piece of steel and then, clink, he dropped it into the pan. He cleaned up the wound, put a bandage on the cut, and gave me a tetanus shot and proceeded to chew my ass for not taking care of it right after I got hit...I told him that I didn't know I was hit - I didn't know that shrapped was in there until it recently showed up."

Since this operation happened after the war and cease fire agreement, Dan was not awarded the Purple Heart.


As I continued the interview, Dan expressed some embarrassment to even call it a wound since so many others had more serious injuries or lost their lives. This is so typical of the humility that our Veterans have and especially those who were in combat and have the mental scars from seeing their comrades wounded and killed in action.

Some history: before WWII the Japanese military occupied Korea and forced the Korean people to harvest their resources, and hence a lot of the trees were cut down and taken to Japan. So the trees that were growing during the time Dan was there were new growth, and other areas were barren because of over-harvesting by Japan.

The men had to march up a path each day to the new ridge.

The various companies found what flat area they could to build their own little campsites where they would live in tents.

October 1953 "Costello coming up the hill from the hall. Hungry guys standing in the chow line" They were heading back up to the front to continue building the new defensive line of trenches and bunkers.



November 1953 Blasting a bolder in the trench. They took the picture from behind a tree and still almost got clobbered by a rock.

Explosives Engineers would come in and do the blasting and then Dan and the other men in the company would clean up the debris in the trenches.

Korean civilians were hired to carry these 8x8 timbers up the hill to this location
These timbers formed the roof of the bunker before sand bags were placed on top.
